# **News From The TPOA**

## It Is Hard To Believe But ... Winter Is Coming

Winter hours begin November 1st for Hampton Park and the facilities at Compton Park.

Winter Hours 8 AM - 9 PM\* Mon - Sat 8 AM- 8 PM Sunday



\* Compton will continue to have late night events in the clubhouse Friday and Saturday evenings until 10 PM.

### **Compton Pool Opening Rules**

The Compton Park Pool opens at 9 AM everyday weather permitting <u>if there are residents wishing to swim.</u>

- 1. The pool is covered each night with a heat-saving cover.
- 2. The pool will not open until the outside air temperature, measured at Compton Park with an outdoor thermometer, reaches a minimum of 50 degrees.
- 3. Even if the temperature reaches 50 degrees, the pool cover will not be removed unless residents have indicated that they wish to swim at which time the park attendants will open the pool.
- 4. If it is raining, stormy or windy, the pool cover will not be removed.

Opening the pool during the winter months is time consuming due to the pool cover. To do so safely requires about thirty minutes. It is suggested that on cold mornings any resident interested in swimming do the following:

- Call Compton Park to inquire as to if the temperature has reached 50 degrees.
- Advise the park staff that they wish to swim and ask to uncover the pool.
- Residents should expect that the pool will be open within 30 minutes of their call.

There are three ways to vote in the 2020 General Election:

- 2. Early Voting see below for dates and info
- 3. Election Day Voting see below for dates and info

## Early Voting: October 19 - November 1, Time 7 a.m. - 7 p.m.

If you are registered to vote in 2020 in Hillsborough County, you can vote at any Early Voting site, one close to home or conveniently close to work.



This is different from Election Day voting when you must vote in your precinct.

The New Tampa Library is an early voting site and less than 5 miles from Tampa Palms.

## **Getting Through It Together**

The Covid 19 crises has had and continues to have a major impact on Tampa Palms in a multitude of ways, not unlike the City of Tampa or country in general. There are known cases of Covid in many, if not most, Tampa Palms villages.

Every family makes its own decisions on how best to protect its loved ones. The Tampa Palms community supports residents' health and safety in a number of ways:

- Reasonably making recreation amenities available for resident use:
  - ◊ The playgrounds in the parks Compton, Hampton and Amberly are open. A place to get out and play is

important for the children and parents alike. To the degree possible, groups from different families are encouraged to practice separation on the playgrounds.



◊ The pools, tennis, racquetball, pickleball, basketball courts, along with the trails and picnic areas, are all open and in use community-wide.



- Opening Compton Park for meetings has been approved while limiting gatherings to less than ten attendees.
  - ♦ This allows boards and small groups such as sewing circles to meet.
  - ♦ Social distancing is required
  - ◊ The pavilions of Hampton, Amberly and River parks are also available for outings and limited to groups of 10 or fewer

Use limitations are re-evaluated monthly. The current ten person limitation was set 9/17 and will be re-evaluated on Oct 18 and adjusted if the situation changes.

## **Community Must Continue To Operate**

The work of overseeing the community by transacting business in the absence of everyone gathering at the same time and location must continue for the good of Tampa Palms, even despite the interruptions caused by the Covid 19 pandemic.

Transacting business without large gatherings has been greatly helped by:

- The governor's Emergency Orders
- The emergence of conferencing applications (both video and audio) that are available to everyone.
- Working remotely, now becoming a new norm, is more comfortable as a way of operating due to the COVID-19 pandemic
- The CDD began to use Zoom technology in May for the monthly meetings. Some supervisors met at Compton, along with a few residents, and everyone else was "virtual".

Both the TPOA and the CDD have used Zoom for community meetings. A screenshot of the July 2020 CDD meeting is shown.



The *TPOA Budget and Annual Meeting* went the next step. The meeting was held via Zoom but for this meeting a remote camera was added, allowing those who were participating remotely to see those present at Compton.



# Finishing The Tampa Palms Master Plan

## **TPOST 3 Moves Toward Completion**

Tampa Palms was developed under a Master Plan, accepted first by Hillsborough County and then later by the City.

Called a *Development of Regional Impact* [DRI] the Master Plan specified the type, and location of all land use, residential, multi-family, commercial and wetland or conservation.

The Tampa Palms DRI is in effect even today. It includes three major areas:

- Tampa Palms
- Tampa Palms North
- TPOST 3

In the early 1990's, when the original developers lost their funding, TP North and TPOST 3 were separated from original Tampa Palms.




TPOST 3, located north of Tampa Palms and east of BB Downs, has been the slowest to complete development.

The developer is now proceeding with a 400 unit apartment complex off of TP Blvd, behind the Promenade Apts. and opening onto Tampa Palms Blvd.

There is an application for a standard variance for tree removal at the site of the construction. No application for impact on the conservation / wetlands is in play and the type and quantity of units has been in effect for decades.

The diagram below from 2013 displays the locations for approved development for TPOST 3. The new apartment space is indicated with a red arrow.



# New Water-Use Permit For Tampa Palms

## Ten Year Permit Renewed

The boulevards and parks in Tampa Palms are irrigated using systems located beside Fla Executive Realty in Area 1 and behind Publix in Area 2. These systems:

- Add water from wells to the adjacent ponds
- Use water from the ponds for irrigation



This process reduces the demand for City potable water to be used for irrigation and now with the increases in water rates, saves the owners in Tampa Palms more than \$500,000 a year for the cost of potable water.

Tampa Palms is limited in both the quantities of water it may use by permit and the types of use.

- The water withdrawn from the aquifer and water used for irrigation are measured and reported each month.
- Water from the irrigation systems may never be used to augment ponds for aesthetics purposes.

Tampa Palms use numerous strategies to minimize the water use, from leak detection to low-volume irrigation devices. The SWSFMD chart below shows the actual water used from Sept 2018 thru May 2020.



# **Inquiring Minds Want To Know**

## FAQ's For Living In Tampa Palms

FAQ What is the situation with the path/trail located along portions of the Duke Energy easement; do the TPOA and CDD oppose improvements to the path/trail?

This path extends from Wareham to Compton, stopping at the road crossings, was created or at least paved by the original developers more than 33 years ago.

The power corridor is not within the boundaries of Tampa Palms and is on private property. The TPOA is a traditional HOA and the CDD is a unit of special purpose government, unlike cities and counties which are general purpose governments. **Neither the TPOA nor the CDD opposes improvements**; <u>as organizations</u> both are simply not legally able to fund or directly participate in improvements.

# FAQ What is the situation with regards to county / city plans to connect to and expand the Tampa Palms corridor trail?

The currently published plans do not include any connections between the very comprehensive Hillsborough County Trail Greenways Trail System and the private path/trail on the power corridor.

The current 2020 version (picture to the right) does not mention the Tampa Palms path/trail/ trail. See related article page 7.


# FAQ Since the path/trail along the power corridor is on private property can the City or County make improvements?

That is a question that only the City of Tampa or the county can answer.

## FAQ Is Tampa Palms Blvd scheduled to be repaved in 2021?

The project plan released by the City earlier this year showed the <u>design</u> for a Complete Streets repaying of Tampa Palms Blvd in the FY 2020-21 Budget, and construction in following fiscal year. Hopefully the schedule will remain on target.

The project covers Tampa Palms Blvd from the NW boundary (the power corridor adjacent to Wellington & Hampton Park) and runs east including Tampa Palms west of BB Downs and Tampa Palms east of BB Downs and continues making the circle through TPOST 3, ending at BB Downs across from the Post office.





## Major Trail Closer To Happening

## A Major Greenways Trail For New Tampa May Be A Step Closer

For nearly 30 years the Hillsborough County and the City of Tampa have worked jointly to create a system of interconnected greenways that would provide new opportunities for outdoor recreation, as well as, routes for use that do not involve motorized vehicles.

The Tampa Bypass Canal Trail is planned to connect New Tampa starting from the Flatwoods Park Trail off of BB Downs and moving south to include the Old Fort King Trail, the Cross Country Greenway, and even the South Coast Greenway.



Ambitious, yes.

Is it here now?

Not quite, but a PD&E study that is underway for the gaps in the By-Pass Canal Trail between the completed (Flatwoods) and the partially funded segments.



Flatwoods is a New Tampa treasure with a seven mile paved trail that includes water kiosks every few miles.

The main trail is about four miles of single track trail that winds around the paved loop.

# BENARE OF JAH

## Wastewater / Sewer Overflows Hit Tampa Palms



Sewer back-ups are occurring with more and more frequency. One village in Tampa Palms recently experienced a back-up as sewer water bubbled up out of multiple manholes, flowing down the street and into the stormwater systems which empty into the ponds.



While the flows above appear to be minor, as the neighbors can attest, the stench was awful.... and this was a minor back-up, even though it affected 5 manholes.

The City responded to this situation, found a simple clog





and cleared it quickly using one of their vacuum / jetter trucks.

Many times, especially if the pipes are aging, clearing clogs is not so simple as seen in the picture below from South Tampa.

From time to time Tampa Palms residents see City Wastewater staff along the boulevards and in the villages examining the sewer pipes with cameras to see if clogs are forming or pipes are disintegrating.

## What Causes These Back-Up's

A neighbor asked the City workers what caused the clog last month and the answer was - as it frequently is congealed fat, oil and grease combined with nondissolving wipes creating a "fatberg".

Unfortunately the pandemic may have increased the

incidence of this type of clog due to the greater use of and improper disposal of a variety of types of wipes. That is usually the cause in a location such as Tampa Palms where the pipes are not aging.





## What About Your Home?


Homes may be more vulnerable to sewer back-ups due to the fact that the pipes are smaller and there is typically less flow.

Resident should act to protect their homes:

- Never allow grease to be washed down the drain. Use a paper towel and wipe excess grease from pans and dispose of the towels in the garbage.
- Never flush any type of wipe down the toilet, no matter if it says "flushable" or not.

A sewer back-up in the home or anywhere on an owner's property can be devastating and the owner is responsible for repair and restoration, not the City.

# Keep Safe Walking & Jogging

#### Tampa Palms Is Modestly "Walkable"

Walkability is a measure of how friendly an area is to walking or jogging. Tampa Palms has 18 miles of maintained sidewalks and paths along its boulevards and parks PLUS sidewalks in all of the neighborhoods.

Pictured to the right is the path in Oak Park, constructed of a material that is tree-friendly.

The use of shoulders or drive lanes as a substitute for sidewalks is never a good idea (or legal) in Tampa Palms. It has been noted that some people are walking beside the medians on Tampa Palms Blvd and Amberly. They are risking their lives, as well as, the lives of drivers who may have to swerve to miss them.

To encourage use of the outdoor spaces and the enjoyment of our beautiful Tampa Palms scenery, the CDD provides seating at a number of locations along the paths throughout the community, including:

- Huntington Pond
- Asbury Pond
- Mezzo Pond
- Cambridge Pond
- Compton Pond
- Wareham / Yardley

There is also ample seating in Amberly Park, along and near the pond and in Hampton Park.










## No Increase FY 2020-21 Assessments

The Tampa Palms CDD approved the FY 2020-21 Budget and assessments. While the budget adjusts certain line items versus the prior year (for example the cost for water for the parks and city-owned cul de sacs increased for the CDD just as it did for owners, ditto garbage collection); no increase was approved for owner assessments.

## **Covid-Based Election Snafu Hits CDD**

CDD Supervisor Michael Gibson, long time Tampa Palms resident, TPOA committee member & HOA board president filed the routine paperwork to run for the CDD seat.

This year, due to Covid pandemic, the filing was by email but the filing fee had to be mailed; offices were closed and no drop-off available. Michael's check was duly mailed by US Mail... and vanished. It never appeared by the deadline, even though mailed seven days in advance.

The seat will be declared vacant after the elections and the Board will appoint a supervisor to fill it.

The vacancy was announced at the TPOA Annual Meeting and will be discussed at the Oct and Nov CDD Meetings. Anyone wishing to be considered should simply email the CDD at **CDD.Tampa@verizon.net**.



## What's New Around Tampa Palms?

### **Park Improvements**

Despite the pandemic, Tampa Palms continues to improve and make safer the community amenities for the enjoyment of all of the residents.



New *easy to walk on* carpet and expanded tile "spill zones" were installed in all meeting rooms at Compton.

For enhanced safety, a shed with a fuel locker now is

in place to store everything that might be flammable used at Compton.

River Park is getting a make-over. The bridge rebuilding is nearing completion.

Next steps which are commencing now include much needed improvements to the pavilion, mapping of the park paths and new park signs,







#### **Freshening The Landscape**

As Ms. Maney, former CDD Supervisor and past president of Hill County Growers Association, often

says plants have a definite life span and they should be replaced when they have passed their prime.

For this reason, old entry plantings are routinely refreshed, not modified, just provided with new and different plants.

Stonington's project began last year the very aging ligustrum trees were replaced.



Now that the trees are settled in, the entry plantings were upgraded. The final phase, along the frontage fencing, is in progress now.

The CDD budgets for these replacements annually and maintains a log of what entries will require attention when.

The next entries scheduled for attention are Wyndham and Palma Vista.

The Fall mums have arrived at the main Tampa Palms entries. They will bring cheerful color to owners and guests as the seasons change.





An integral part of the Tampa Palms community, the Tampa Palms Country Club has weathered the pandemic with the rest of us, keeping members and staff safe and even assisting with food donations for shut-in's.
